The Board of Trustees of Batavia Township, Clermont County, Ohio met for a Joint Special Meeting with Pierce & Batavia Townships Session at 6:30p.m., Monday, February 6, 2023 at the Pierce Township Administration Building, 950 Locust Corner Road.

CALL TO ORDER:

Chairman Pete Kambelos called the meeting to order. Trustee Nicholas Kelly, Trustee Allen Freeman and Chairman Pete Kambelos were present at roll call. PURPOSE OF THE MEETING:

The purpose of this meeting is to discuss the joint properties of the former Amelia Village owned by both townships. Meeting may include such other matters as shall come before the Board.

AGENDA ITEMS FOR DISCUSSION:

The trustees discussed sale of the property at 119 W. Main St. This includes 3 parcels that include the Victorian House that was utilized as the former Amelia Village Administration building.

Trustee Sauls of Batavia Township would like to put something out there and start the process of selling 119 W. Main St. Batavia Township Trustees would like to see some progress, especially with the Victorian. It costs both townships money to maintain the structure. (No action was taken by either township.)

Discussion on the former Village of Amelia's records and remaining records at the police station. Both Pierce & Batavia Townships discussed what can be destroyed and cannot be destroyed. Both Pierce and Batavia Townships Administrators to look at what other villages dissolved did with their records.

No date was set with Townships staff to clean out the rest of the buildings of items that were not sold at auction. Items there are items remaining at the police station and the Morse House. Also discussed was getting dumpsters to get rid of the jointly owned items.

Review of appraisals on other jointly owned properties and discussion of final resolution of properties. No discussion on other jointly owned properties.

Joint efforts to improve St. Rt. 125 Corridor. Chairman Kambelos stated this is a great opportunity for both Townships to develop the corridor. This would great for the residents along St. Rt. 125.
