SHERIFF'S DEPARMENT REPORT

Deputy Benkelmann gave the crime stats for April 2023. There was increase of 9.41% in offense reports from last month. The highest crime type was theft. Five or six reports were juveniles. There were 135 offense reports taken by the Deputies and 196 incident reports. There were 34 traffic arrests. The warrants were about the same as last month at 88 and 201 civil services. We had 57 assists to other agencies. There were 20 adult arrests. There were 8 juvenile arrests, and 214 business checks. Deputies took 88% of the Township incident reports and 67% of the offense reports. Property recovered was \$10,000. There were 469 neighborhoods patrolled. There were 2 overdoses in April. There were 3 burglaries. There was 1 report of breaking and entering.

COMMITTEE REPORTS

Mr. Perry gave an update for Central Joint Fire & EMS District. It was suggested to order a new firetruck. They cannot get Explorers at this time. The firetruck that was in an accident is out of service at this time.

Mr. Parsons gave the update for Batavia Union Cemetery. The annual joint meeting with Batavia Village was held last Monday. They will be installing a PolyVault on the hillside this summer.

LARGE SOLAR AND WIND FARMS DISCUSSION

There was discussion on Large Solar Facilities and Large Wind Farms in Batavia Township pursuant to Ohio Revised Code (ORC) Section 303.58.

Karen Swartz gave an overview and started the discussion. There was not a large response to the Survey Monkey that was sent out about the issue.

Jonathon Wocher gave additional information about the classifications, policy and planning issues, area identification, growth policy plan, etc. A resolution will set restriction zones over residential properties. A company would typically need 800-1,000 acres to be a 50-megawatt solar farm. Windmill farms can still be farmed except where turbines are located.

Sara Maloney, UC Professor, spoke against solar farms. She is concerned about our agricultural system being displaced with solar.
