Recognition

The Board of Trustees recognized Nany Cutler, Board of Zoning Appeals, for fulfilling her role as a member. She is very appreciated and will be missed. She was presented a plaque.

SHERIFF'S DEPARMENT REPORT

Deputy Benkelmann gave the crime stats for May 2023. There was a decrease of 10.98% in offense reports from last month. The highest crime type was theft, 31 offenses. There were 133 offense reports taken by the Deputies and 169 incident reports. There were 10 traffic arrests and 28 warnings. The warrants and civil services were up. There were 38 adult arrests. There were 8 juvenile arrests, and a slight decrease in business checks. Deputies took 82% of the Township incident reports and 73% of the offense reports. Property recovered was \$4,778, \$4,000 was a vehicle. There were 384 neighborhoods patrolled. There were 6 overdoses in May. There were 2 burglaries. There were 5 reports of breaking and entering. Mr. Parsons inquired if there have been any issues with the Ford Explorers. Deputy Benkelmann said they seem to be the 2020-2021 models. Several Townships have had problems with theirs. Mr. Sauls thanked all the Deputies for serving our Township.

Jonathan Wocher, Zoning Consultant gave his summary of the case which is a Zone Map Amendment request, located at 3648 SR222. Savion Energy- Solar Farm Update

Karen Swartz introduced Drew Pierson, Cleveland, Ohio, and Eddie Barry, Houston, Texas, from the Clear Mountain Energy Project on Herald Road.

Drew Pierson and Eddie Barry gave an update on the current project and gave their presentation. They are a renewable energy development, mainly solar, based in Kansas. Ohio is a main focus area for this company's projects. There are 104 acres in Clermont County to be utilized for this project, and no more. All environmental and field studies have been completed. All land south of SR 276 is under purchase option agreement. The rest of the land is leased.

Solar panel safety, storm water prevention plan, and flood sensitive areas were discussed. Mr. Parsons asked about an area of trees; they will not be removed. The intent is to preserve trees, and design around the forested areas. Mr. Sauls questioned repowering. It would require new lease agreements.

TOWNSHIP ADMINISTRATOR REPORT

Karen Swartz submitted three areas/projects for the grant from House Bill 377.

Our electricity contract was renewed with Energy Harbor. Letters went out on May 19th. The current rate is 4ϕ , the new rate will be 6ϕ . This is electric only. Participation in the aggregation will save the residents money.

Karen researched fishing tournaments for our pond at the Township Park. Karen and Cody will work over the winter to get this organized.

The signs are being repainted.

We continue to have issues with the bathroom door. Karen called Perkins two weeks ago. Mr. Perry suggested we get an extended warranty and have a door rep. come here as well.

Karen spoke with Jonathon about the back entrance to Hanger Flats and the drainage issue. There have been no complaints. A berm is being built there.

Mr. Patel sent a letter requesting to purchase property on Olive-Branch adjacent to his current business.

Karen met with the representative from Republic Services as we are at the end of the 5-year contract. Karen will get more information about rates.

We completed the sexual harassment and bullying training. Driving record checks were done as well.

Nick Goslin will become the road patrol captain and Captain Allen will transfer to another unit.

The VFW is seeking a donation for the Memorial Day expenses.

Karen spoke with PES Group about the playground equipment proposal. They would like to meet with the Board on June 13th at 2:00 p.m. Karen will notify the media about the meeting which is about park improvements.

ZONING ADMINISTRATOR/INSPECTOR REPORT

Taylor Corbett gave the May report. For May, we've had 5 single-family permits from Rosewood, 5 from Heritage Farms, 1 from Derby, and 1 from Billingsley. There are 111 multifamily permits from Redwood, and 3 in Billingsley. Comparing 2022 to 2023, we are down a bit from 2022 due to the high interest rates. There have been 119 permits in 2023.

Taylor gave the Inspector's report for Brad Harris. There are 3 cases of vegetation issues.

The Zoning Commission will hear one case on June 8th requesting approval for one acre.

There is one BZA case to be heard June 26th. Safe Harbor of Hope will be requesting a conditional use permit under B2 Zoning.

Taylor is the County Appointee for the airport master plan scoring committee. There were 2 submittals for the master plan.

Taylor met with a business looking to relocate to Batavia Township.

There have been no new PUD updates.

SERVICE DIRECTOR REPORT

Cody Smith, Service Director gave the May report.

We repaired a catch basin on Wulfert that became a sink hole.

The paving at Burnham Woods was completed. There were issues and Cody had it checked out Barrett Paving will be re-doing the surface.

The footers and leveling of the graves have been completed before Memorial Day.

We have a quote to repair the two truck beds. Cody will check to see what a new bed would cost.

The repair quote for the current vac truck is \$20,000.

Mr. Sauls gave an update for Central Joint Fire & EMS District. They are hiring 7 new employees, some of which are replacements.

Mr. Parsons gave the update for Batavia Union Cemetery. There was an extensive summary by Steve Shinkle at the last meeting. We had about 50% that were cremations last year. This year it has been about 5% that were cremations. We meet again tomorrow night.

We need another alternate for the BZA Board.

OLD BUSINESS

Mr. Parsons asked the Trustees to consider having concerts, movie nights, etc. at the Township Park. It is important we highlight this property for our residents as well as other communities. There were ideas suggested by staff members. Volunteer Boards/Committees would be of benefit for these events. We will start with quarterly events.
